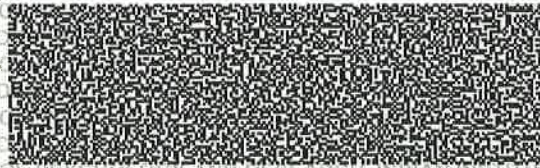

**WHEREAS** the parties herein desire to reduce the terms and conditions agreed upon into writing by way of Memorandum of Understanding;

**NOW THEREFORE THIS MOU WITNESSETH AS FOLLOWS;**

### 1. SCOPE OF THE PROJECT -

- a. The First Party for the benefit of the Second Party shall develop the Project that is develop Psychological scale using standardized procedures of psychometric assessments, run pilot study, standardize it and provide the same for the use of the Second Party.

- b. The First Party in order to carry out the project shall constitute the required expert committee which will conceptualize, execute and review the project at various stages.
- c. The First party will recommend to the Second Party a suitable candidate as a project assistant who will liaison between both the parties by way of visiting the respective locations to study, understand and assist in the project.

## **2. COMMERCIAL TERMS -**

- a. The Second Party shall pay a sum of Rs.1,50,000/- (Rupees One Lakh Fifty Thousand Only) to the First Party as consideration for the project.
- b. Any additional consultation charges other than for the purpose of this project shall be chargeable by the First Party to the Second Party at Rs. 2500/- (Rupees Two Thousand Five Hundred Only) per hour/per expert.
- c. The Second Party shall pay the remuneration to the project assistant as per the pay scale applicable for research assistants for the duration of the appointment (six months to one year).
- d. All the Travel, Food and Accommodation for the project assistant shall be borne by the Second Party and the First Party shall raise invoices to the Second Party towards these expenses on actual expenditure basis.

  - b. The Second Party has paid the first instalment of Rs. 75,000/- (Rupees Seventy Five Thousand Only) to the First Party on signing this MOU receipt of which sum of Rs. 75,000/- (Rupees Seventy Five Thousand Only), the First Party hereby acknowledges.
  - c. The Second Party shall pay the balance project cost of sum of Rs. 75,000/- (Rupees Seventy Five Thousand Only) on completion of the project and at the time of handing over the final tool that is the duly completed Study-the Project.
4. The entire project shall be completed by the First Party within 12 months from the date of signing this MOU.

### **5. RESPONSIBILITIES OF SECOND PARTY -**

- a. The Second Party shall provide to the First Party all the information required for the completion of the study-project.
