With reference to your application for Maternity Leave, I hereby approve your request and sanction leave as per the following regulations-

1. You will be sanctioned 180 days / 6 months(apprx) of Maternity Leave without any break in your service continuity.
2. The period of leave starts from 30th of April 2022 and ends by 26th October 2022. You are required to report for duty from 27th October 2022
3. To support lactating mothers on resuming work you will be given one hour break prior or post lunch break. Rest of the workload and schedule remains unchanged.
4. During the period of leave you should be ready to render all possible support for the smooth functioning of the institution in your absence by way of information sharing, online work, responding to email queries and guidance to the ad-hoc faculty.
